Constitution & Bylaws Changes: We will bring up the proposed changes to the constitution & bylaws at the next meeting where a quorum is present.

Future Location of Meetings: We're still looking for a location to hold our meetings. Caribou Coffee will serve as our backup, but we will try meeting at Washington Square (17 & Connecticut) for the next meeting.

Member Initiation: Due to time constraints, we will not plan to hold member initiation in conjunction with the Washington DC Conference.

Auction with Post 1: Post 1 has moved from the idea of having an auction with an auctioneer. The thought currently is to sell items on eBay and/or Craigslist and have a yard sale for other items. Debbie Chen suggested having the yard sale portion in conjunction with a high school's yard sale and the silent auction could be hosted on a site dedicated to silent auctions for non-profits. Debbie Chen has also secured some additional leads on items.

National's Washington DC Conference: At the Auxiliary's annual Washington DC Conference, the opening session is open to all members of the Legion Family. Servicewoman of the Year National Award: We have a candidate for Army and Air Force in mind. Members will do further research for candidates in the Coast Guard, Marine Corps and Navy.

"Where Are They Now" Research: in conjunction with the Cavalcade of Memories and National Historian Plans of Auction, we will look at our members to submit information to the National Historian on Auxiliary members "who did something exciting, new or different in America outside of their membership." So far, we will submit: (1) Denyse Gordon as the first Ms. Veteran America, (2) Barbara Riegsecker as the first female ROTC cadet to graduate from Mercer University and (3) Sharon Riegsecker as a member of both the first and second class of the American Legion Auxiliary Call to Service Corps.
